Description:

Coordinator Two builds on the foundational material provided in Coordinator One and introduces many of the non-sexual harassment Title IX topics including pregnancy, minors, athletic equity, and intersection with Section 504 and the Americans with Disabilities Act (ADA). This course also covers crossover between Title IX and the Violence Against Women Act's (VAWA) amendments to the Clery Act, a brief discussion of climate surveys and prevention programming, and tips for structuring and evaluating your Title IX Team.
