

# 2020 Title IX Regulations Refresher for Higher Education Training & Recertification Course Agenda

#### **Description:**

This newly revised and updated one-day 2020 Title IX Regulations Refresher course is for Title IX Coordinators, Investigators, and Decision-Makers – those who have experience with the 2020 Regulations, especially those who have previously been certified in the 2020 Regulations by ATIXA.

The removal of the 2024 Regulations necessitates specific attention and re-training on the more proscriptive 2020 Regulations. With all the back-and-forth of different regulatory schemes, we're all a little rusty and in need of keeping the 2020 nuances front of mind. As Title IX compliance, regulations, and oversight evolve, we also face heightened scrutiny from the Executive Branch, particularly from the Departments of Education, Justice, and Health and Human Services, as well as ongoing litigation and caselaw. This Refresher training aims to fortify participants' understanding of compliance obligations under the 2020 Regulations, while addressing the challenges posed by the evolving legal and regulatory environment.

Participants will benefit from engagement with ATIXA's expert faculty who share examples, best practices from our extensive experience, and answer participants' questions to help your institution face the challenging and complex environment surrounding Title IX Compliance.
