Simple steps for submitting your comment on OCR's proposed Title IX Regulations:

- Read and understand the regulation.
 - o For a copy of the proposed regulations, click here:

- In your comment:
 - o Be concise but include support for your views
 - Support can include published articles, statistics, quantitative and qualitative data, legal cases, etc.
 - o Organize and identify the issues you are addressing
 - o Constructive comments (presenting alternatives, examples) are most effective
 - o You do not need to address every issue presented in the proposed regulations
- No minimum or maximum length for comment
- The comment period closes on **11:59 p.m. E.S.T on January 28, 2019**
